

## Notes to the Authors

We thank you for your interest in the African Integration and Development Review (AIDR) through your submission. The Articles submitted to African Integration and Development Review (AIDR) are assessed anonymously by at least two external evaluators. The Review does not accept to articles published simultaneously elsewhere. Moreover, once the article is accepted, the author cannot withdraw it without the consent of the Editor. The views expressed by the authors are not the responsibility of the Review.

The draft articles submitted to the African Integration and Development Review should not exceed 30 pages (Garamond 12, double-spaced) or 60 000 characters (with spaces), including tables, graphics and the bibliography. The articles must be accompanied by a summary in French and English (abstract) in not more than 100 words each, the keywords (French and English, up to 5) and the JEL classification (5 references maximum). The title of the article should also be in French and English. The authors should specify the following information about themselves on the first page: Name, First name affiliation, email address, phone number, and mailing address.

The bibliography must be prepared as follows:

- In the text, indicate the references in the author-date format, for example: Kouassi (1998) or (Abebe, 1987, p 10-13.) or (Makeba, 1990, chap. 2).
- The bibliographic references should be established, in alphabetical order, for an author, from the most recent year to the oldest, as follows:
  - For articles published in journals or periodicals: J. Stiglitz, Weiss A. (1981) Credit rationing in market with imperfect information, *American Economic Review* 71 (3), 393-400.
  - For books and reports: Malinvaud E. (1991) *Voies de la recherche macroéconomique*, Ed Odile Jacob, Paris, p 507..
  - For articles in a book: Azam J-P. (1988) *Examen de Quelques Problèmes Economiques Soulevés par la Méthode d'Analyse des Stratégies*. In *Stratégies de Développement Comparées*. Under the direction of Patrick Guillaumont and Sylviane Guillaumont Ed. Economica, Paris, pp. 157-164.

The authors must comply with the following additional instructions:

- the graphics and figures should be provided in the form of images - jpg or .png in order to facilitate processing and reproduction.
- All equations, symbols and formulae should be written in Microsoft Equation Editor 3.0 or Math Equation type and numbered ascendingly.
- Quotations exceeding five lines should be indented and without quotation marks.
- Explanatory Notes, absolutely necessary, should be limited, numbered consecutively and presented as foot notes.
